

Located in the heart of downtown Ogden, Youth Futures opened Utah's first homeless residential youth shelter on February 20, 2015. We provide temporary, overnight shelter beds and day-time drop-in services to youth, as well as intensive case management to help these youth become reunited with family or self-sufficiently contributing to our community. Our programs connect each youth, and on individual bases, with resources to build the skills that are needed to support a healthy future. Each youth is guided in a loving, supportive and productive way, so as to encourage their own personal path for their future. We always collaborate with the youth's family of origin, first, to facilitate understanding and re-unification.
